The Village Council of Bradner, Wood County, Ohio met in regular session on the 21st day of September, 2017 at 7:00pm in the meeting room of the Village Hall. The meeting was called to order by Mayor Virgil Shull and all in attendance were asked to stand for the Pledge of Allegiance to the Flag. Street Commissioner Chuck Ruble, Police Sergeant Jeremy Salaz, Fire Chief Jim Smith, Solicitor Corey Speweik and Fiscal Officer Kerstan Kaminski and Guest Tammy Stahl was in attendance.

### RECOGNITION OF GUEST(S)

Jim Smith (BPA): Jim previously asked Council to look at 2 specific street lights on Main Street, both LED's. These should have 40% reduction in usage. They will meter them and move them around town to verify 40%. If Council is interested, the Board will negotiate the price first and verify the savings. If the savings is there, the Board will begin with Main Street and downtown which has 27 lights and would be around \$14,000. The price could go down if negotiated. The lights taken down will go on Govdeals. Several Councilmembers are hesitant since the lights are still working. Decorative lights downtown were also suggested which is a possibility. Linda Wildman will be on a Street Lighting committee along with Mike Gudakunst. Ray Zaker will also be on the committee.

There is a resolution for the Alltel contract. They want to update the antennas that are on the water tower. There is now an upchange to the contract. Jim is checking on what the upchange is.

Jim read the letter from Corey regarding advertising for other businesses by the Village. Setting a fee schedule is recommended. Council doesn't see why they should charge now since they haven't in the past. Corey gave the example of the Village of Elmore putting up a nativity scene and being sued by a group from Washington and the Village of Luckey and Jehovah's Witnesses. Discussion was had regarding how many could be in each mailing, what the charges would be and how they would decide who gets in the mailings.

Advertising for the Storm Sewer project went out. The bid opening is October 5 at 11am at Town Hall.

Jennite put together a price to redo certain streets in town. The pricing includes grinding them down and the curbs will then be visible if they are there. Main St, Railroad St (from Crocker to Main), East Parklane and Spring St are the streets to possibly be done. West Parklane could also be done if the residents want it on their taxes. He still needs to get 2 more bids.

Regarding a Councilmembers question, property owners are responsible for cleaning their own sidewalks. Zoning would have to send a letter. Also, John Raymond has been cleaning curbs on his own. Chuck is picking it up when he is done.

Chuck is working on putting up new speed limit signs.

There was concern regarding the park bathrooms not being clean last weekend. Chuck will check into it.

Morelock has started power washing the shelter. Kerstan has his liability insurance but he does not need Workers Comp if it is just him. It was not him power washing, it was someone else.

#### **OLD BUSINESS**

Mike G Twp EMS- Corey received a draft of a resolution from Julie Burton yesterday. The draft includes Bradner. Corey suggested to Wayne a resolution of intent. Bradner should do the same. This is not a permanent commitment. The millage should be no higher than 6.5 mills. They've done a study. Julie said the County Auditor wouldn't provide numbers until there's a commitment. Risingsun valuation is 5,516,620, Wayne is 9,007,480, and Bradner is 11,107,490. Montgomery Township valuation is 75,726,480.

There are 2 major steps. The first is to create a joint district. Then it needs funded by vote of people with presented millage. The vote will only go to the entities participating and if passed, they will be the only voters taxed.

Corey noted that the intent to participate does not need to be in writing, it is not binding. It is just showing support and courtesy. When it comes to the actual ordinance passing, votes can be changed.
