The Village Council of Bradner, Wood County, Ohio met in regular session on the 5th day of October, 2017 at 7:00pm in the meeting room of the Village Hall. The meeting was called to order by Mayor Virgil Shull and all in attendance were asked to stand for the Pledge of Allegiance to the Flag. Street Commissioner Chuck Ruble, Police Chief Chuck Broshious, Fire Chief Jim Smith, Solicitor Corey Speweik and Fiscal Officer Kerstan Kaminski and Guest Joy O'Donnell and Tammy Kreais were in attendance. RECOGNITION OF GUEST(S)

Joy O'Donnell: She asked for minutes and financials from the CIC. CIC currently has \$93,000. \$9,463 is left in general fund for the year. The Prosecutor said the initiative petition for the kilowatt tax to go back to the CIC was unconstitutional. Joy asked if it's unconstitutional now, was it unconstitutional the first time. The action is not unconstitutional, but it cannot be done by initiative petition. Initiative petitions can only exercise legislative authority, not administrative.

Joy would like Council to request the money back from the CIC. CIC could pay for the Christmas Lighting Contest. CIC has more money than general fund. CIC spent \$17,000 in 2016. Money went to CIC in 2011.

Linda Wildman made a motion for Council to ask the CIC to return the money to help with General fund. Ron Roth 2nd.

Tammy Kreais: Council knows there is a possibility of being sued. Virgil and Ray are on the CIC. Virgil and Ray can't be excluded as elected officials from Executive Session. She would like Council to remember they're elected by the Village to make the best choices. She said previously, not to upset the taxpayers and to think for the Village and vote yes for the township EMS. The Village is not protected. The number of runs on the website has not been updated since April which was 23.

She also does not want another emergency vote to happen.

FIRE CHIEF - Jim Smith

Measel invoice is in the bills. The new a/c is working.

Jim had to call Applied Imagination for a noise in the computer. It was back Tuesday morning.

The Fire Safety bill was for 12 valves for the new air tanks. The company had the wrong address to send the bill to.

Ardent Technology burnt images to usb drive for the Police. Jim asked to replace 2 cameras and update the software for \$2,500. The cameras are only a few years old. Council would like Jim to get some additional quotes.

Jim asked Chuck to get bags of leaves, brush, etc. out of the brush pile. Chuck hasn't been able to get to it yet.

The contract for Perry Township was sent to their Prosecutor. There are a few words that the Prosecutor would like changed.

The Fire Dept. received a thank you for the barn fire they responded to and a thank you package from a previous barn fire.

Tammy would like to see reports each month for the number of runs for the Fire Dept. She was also told that more turnout gear is expired. They expire in increments. She counted 22 members on the Fire Dept.
