STREET COMMISSIONER - Chuck Ruble

BUSINESS OF THE MAYOR

Virgil still has not heard back yet on Douglas Road project. He sent an email but it didn't go through. Kerstan has not heard anything about it.

He asked if Randy with Ardent stopped in about the cameras. He has not.

Jim got a quote to paint the pool house for \$8,430 from Nahmo Enterprises. Kerstan mentioned she used to work for someone who has a painting company, and believes they did work here also. Jim said this company will also point the blocks that need done, pressure wash and then paint. Lori asked if the pool is going to open. Virgil responded that we still need more lifeguards. There are only 2 as of now. The pool is ready to be filled as soon we have the lifeguards.

FISCAL OFFICER – Kerstan Kaminski

May financials are done.

Fuel Mart will be closed as of July 4 for 120 days. They are tearing down and rebuilding.

Kerstan sent the letter to the CCA to notify them the Village will be handling residents' income tax returns starting in 2017.

OLD BUSINESS

Virgil asked if the Council wants to widen the street 5 feet. Lori asked if it will hurt the street further down and if going 2.5 feet into the right-of-way will cause residents to lose 2.5 feet into their yard. Virgil said only one tree might have to come down since they are only doing 2.5 feet on each side and they cannot go any further into the yard than the right-of-way is. No one will lose their front yard. Chuck R. asked about how they will pay for it. Virgil said they will borrow from themselves just like they did last time. Chuck R. suggested waiting until the waterline is completely done and then doing the entire curb altogether. Linda thinks that Chuck should've known about B. Hillz being here since he's the Street Commissioner and they tore up the street when they were replacing the waterline. She also wants to know if it can be guaranteed that it will be smooth and not bumpy like when Lightner was done. Virgil said they will have to spend the money to do it right. Jim said once Main Street is done, 50% of the waterlines will be replaced. They are either going to put the curb back exactly where it is now, or moving it back 2.5 feet if Council wants to do the other side.

Lori asked about Douglas Road and if the Village gets that grant, do we have the money for that. She knows there are streets in town that also need replaced and then adding the street widening as well, she's concerned about the availability of money. Virgil said Douglas Road will come out of Storm Sewer Capital. The Village only committed \$100,000 of the \$199,000 available in that fund. The funds being used for this project is different than Douglas Road and repairing the streets.
