

ORDINANCE NO. 08-2016

AN ORDINANCE SETTING WAGES AND SALARIES FOR VILLAGE POOL LIFEGUARDS AND THE POOL MANAGER; ESTABLISHING FEES AND THE RULES GOVERNING POOL MEMBERSHIP, ADMISSION AND RENTALS, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Bradner owns and operates a public swimming pool for the use and enjoyment of the public; and

WHEREAS, the Village must employ several people in order to operate and maintain said swimming pool in order to ensure the health, safety, and welfare of the public; and

WHEREAS, pursuant to RC §731.13, from time to time, the compensation of said employees shall be fixed by Council, the last such time having been June 6, 2013 through Ordinance 12-2013; and

WHEREAS, from time to time, the fees and rules for use of the pool may be fixed by Council, the last such time being June 6, 2013 through Ordinance 12-2013 ; and

WHEREAS, the Village desires to amend said Ordinance 12-2013 in order to fix such wages, salaries, fees, and rules for the year 2016 and beyond until such time said wages, salaries, fees, and rules may modified by Council.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BRADNER, COUNTY OF WOOD, AND STATE OF OHIO THAT:

SECTION 1. Ordinance 12-2013 shall be amended as follows:

SECTION 1. The Pool Manager shall be paid \$10.00 per hour and shall work at least forty (40) hours per week, with one-half (50%) of said wages being paid from the Pool Fund and one-half (50%) being paid from the Park Fund. In addition to said base pay rate, any returning employee who has previously worked for the Bradner Pool shall receive an additional \$0.10 per hour for each year of previous employment with the Bradner Pool.

SECTION 2. The Head Lifeguard will be paid a base rate of \$8.10 per hour, to be paid from the Pool Fund. In addition to said base pay rate, any returning employee who has previously worked for the Bradner Pool shall receive an additional \$0.10 per hour for each year of previous employment with the Bradner Pool.

SECTION 3. The Lifeguards will be paid a base rate of \$8.10 per hour. In addition to said base pay rate, any returning employee who has previously worked for the Bradner Pool shall receive an additional \$0.10 per hour for each year of previous employment with the Bradner Pool.

SECTION 7. The annual Family Membership fee, for up to six (6) members in a family, is \$165.00 for Village residents and \$175.00 for non-residents and shall include five (5) complimentary passes. Additional family members will be charged \$20.00 per person, per year. Annual Individual pool memberships shall be \$75.00 for Village residents and

\$80.00 for non-residents and shall include three (3) complimentary passes. Annual Senior Citizen memberships for persons 62 years and older (calculated as of the date the membership is purchased) shall be \$45.00 for Village residents and \$50.00 for non-residents. Annual membership passes are valid through the last day of the operating season in which they were purchased.

SECTION 8. The daily admission fee will be \$3.00. Children ages 6 and under are free.

SECTION 9. Special group rates for use of the pool shall be as follows:

a. Large Group Rates: The admission charge for groups of 25 or more persons intending to use the pool at the same time, shall be \$2.00 per person per day, provided the group registers with the pool manager in advance.

b. Exclusive Rental by Groups: The rental rate for reserving the exclusive use of the pool by groups of up to 30 persons shall be forty dollars (\$40.00) per hour. The rental rate for exclusive use of the pool by groups of 31 to 75 persons shall be eighty dollars (\$80.00) per hour. The rental rate for exclusive use of the pool by groups of between 76 and 125 shall be one-hundred twenty dollars (\$120.00) per hour. For safety reasons, groups over 125 people may be refused.

SECTION 2. Any portion of Ordinance 12-2013 which has not been specifically amended herein shall remain in full force and effect.


SECTION 3. This ordinance constitutes an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the Village of Bradner, and shall go into immediate effect upon the passage thereof. The reason for the emergency is that the pool is about to open and it is necessary to establish wages, salaries, fees, and rules so that the pool can be operated in a safe and efficient manner.


