

**AN ORDINANCE SETTING POOL FEES, RATES, AND RULES FOR THE PUBLIC POOL WITHIN THE VILLAGE OF BRADNER, OHIO AND DECLARING AN EMERGENCY**

**WHEREAS**, the Village of Bradner owns and operates a public swimming pool for the use and enjoyment of the public; and

**WHEREAS**, the Village must employ several people in order to operate and maintain said swimming pool in order to ensure the health, safety, and welfare of the public; and

**WHEREAS**, from time to time, the fees and rules for use of the pool may be fixed by Council, which Council has so fixed through Ordinance 4-2012 (passed June 7, 2012), which was amended by Ordinance 12-2013 (passed June 6, 2013) and Ordinance 8-2016 (passed June 2, 2016); and

**WHEREAS**, said Ordinance 4-2012 was repealed on July 6, 2017 by Ordinance 9-2017; and

**WHEREAS**, said Ordinance 12-2013 was repealed on July 6, 2017 by Ordinance 10-2017; and

**WHEREAS**, said Ordinance 8-2016 was repealed on July 6, 2017 by Ordinance 11-2017; and

**WHEREAS**, the Village desires to fix such fees and rules for the pool for the year 2017 and beyond until the same may modified by Council.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BRADNER, COUNTY OF WOOD, AND STATE OF OHIO THAT:**

**SECTION 1. MEMBERSHIPS**

A. Beginning July 1, 2017 and continuing through the close of the pool in year 2017, the annual Family Membership fee, for up to six (6) members in a family, is \$50.00 for Village residents and \$75.00 for non-residents. Additional family members will be charged \$20.00 per person, per year. Annual Senior Citizen memberships for persons 62 years and older (calculated as of the date the membership is purchased) shall be \$45.00 for Village residents and \$50.00 for non-residents. A single 10-day pass can be purchased for \$25.00. Annual membership passes and 10-day passes are valid through the last day of the operating season in which they were purchased.

B. Beginning at the open of the pool in the 2018 season and thereafter, the annual Family Membership fee, for up to six (6) members in a family, is \$165.00 for Village residents and \$175.00 for non-residents and shall include five (5) complimentary passes. Additional family members will be charged \$20.00 per person, per year. Annual Individual pool memberships shall be \$75.00 for Village residents and \$80.00 for non-residents and shall include three (3) complimentary passes. Annual Senior Citizen memberships for persons 62 years and older (calculated as of the date the membership is purchased) shall be \$45.00 for Village residents and \$50.00 for non-residents. A single 10-day pass can be purchased for \$25.00. Annual membership passes and 10-day passes are valid through the last day of the operating season in which they were purchased.

**SECTION 2. DAILY ADMISSION**

A. The daily admission fee will be \$3.00. Children ages 6 and under are free.

SECTION 3. GROUP RATES

Special group rates for use of the pool shall be as follows:

- a. Large Group Rates: The admission charge for groups of 25 or more persons intending to use the pool at the same time, shall be \$2.00 per person per day, provided the group registers with the pool manager in advance.
- b. Exclusive Rental by Groups: The rental rate for reserving the exclusive use of the pool by groups of up to 30 persons shall be forty dollars (\$40.00) per hour. The rental rate for exclusive use of the pool by groups of 31 to 75 persons shall be eighty dollars (\$80.00) per hour. The rental rate for exclusive use of the pool by groups of between 76 and 125 shall be one-hundred twenty dollars (\$120.00) per hour. For safety reasons, groups over 125 people may be refused.

SECTION 4. This ordinance constitutes an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the Village of Bradner, and shall go into immediate effect upon the passage thereof. The reason for the emergency is that the pool is about to open and it is necessary to establish fees, rates, and rules so that the pool can be operated in a safe and efficient manner.


SECTION 5. All formal actions of Council relating to the adoption of this ordinance, and all deliberations of Council and any of its committees leading to such action were in meetings open to the public as required by law.
