Resolution 16-2017

JOINT RESOLUTION TO CREATE A JOINT AMBULANCE DISTRICT

WHEREAS, the Board of Trustees of Montgomery Township and the Council of the Villages of Bradner, Risingsun and Wayne, all in the County of Wood, State of Ohio, have determined that there exists a real need within their various jurisdictions to provide emergency medical services to their citizens; and,

WHEREAS, the Board of Trustees of Montgomery Township and the Council of the Villages of Bradner, Risingsun and Wayne, all in the County of Wood, State of Ohio, desire to form a joint ambulance district to be known as the South East Ambulance District, pursuant to RC §505.71, et. seq., for the purpose of providing ambulance and emergency medical services to the residents within the proposed district; and,

WHEREAS, the board and councils of the above jurisdiction of said district desire to include all of Montgomery Township and the Villages of Bradner, Risingsun and Wayne, all in the County of Wood, State of Ohio, as shown by the map attached and hereby incorporated by reference; and

WHEREAS, the board and councils of the above jurisdiction of said district acknowledge that the operation costs of said district will likely exceed \$500,000.00 per year, based upon several variables, including but not limited to the number of participating entities and other costs which are not yet able to be precisely determined; and

WHEREAS, the board and councils of the above jurisdiction anticipate that in order to fund said district, it will likely be necessary to utilize one or more revenue sources which may include a levy, bond, or other mechanism permitted by statute.

THEREFORE, BE IT RESOLVED, that the Board of Township Trustees of Montgomery Township, located in the County of Wood, State of Ohio and the Village Council of the Villages of Bradner, Risingsun, and Wayne, located in the County of Wood, State of Ohio, hereby create a joint ambulance district comprised of the municipal corporations of Bradner, Risingsun, and Wayne and Township of Montgomery, by a majority vote of the members of their respective board or council as indicated by their signature below; and be it further,

RESOLVED that the South East Ambulance District herein created shall begin to operate as of January 1, 2018.
