Steve Beck: He would like to use the park the 2nd (or 3rd if 2nd not possible) weekend in November, Friday - Sunday. They will be cooking over the fire, dutch oven cooking, camping in tents and making rope. They will need to have the restrooms open. It is open to the public. Northwest Pools does not do the skimmers, another contractor will do them. He did say there are leaks in the skimmers and the return lines. There will be a lot of concrete and it will not be cheap. They will be continuously working on the pool. Cody suggested that maybe the repair guy could come to a meeting to explain.

Tammy asked about Douglas Rd. Virgil stated nothing will be done for now. There is no money for this right now. Tammy suggested having monthly meetings to discuss the streets to be done next.

Tammy mentioned that the pool house and bathrooms look good. The Park & Pool Board are talking about a wireless camera system at the park. Tammy and John painted the fire truck and then it was vandalized. They will be fixing it next week. Chuck said the toilet dispensers are broken in the bathrooms. The police officers are already driving pass the park and sitting there at different times but it is still happening.

STREET COMMISSIONER - Chuck Ruble

The crossovers are done and the concrete is poured. They just need to fix the yards.

The brush pickup will start tomorrow.

There is an extra catch basin on the bill for East St. Virgil asked Chuck to check the storm sewer cover by the stop sign by Doris'. He drove by and it was off.

Chuck will be off next Wednesday-Friday for vacation.

POLICE CHIEF – Chuck Broshious

There is a bill for \$90 for the rear end seal of the Crown Vic.

The officers are looking for vehicles parked facing the wrong way but have not seen any yet.

There have been u-turns by the post office, which are allowed at intersections, but are almost causing accidents. The Solicitor is writing up an ordinance.

Ron asked if licensed 4-wheelers are allowed on the streets. Yes, as long as they are plated.

FIRE CHIEF - Jim Smith

The second cot arrived on Monday. 626 will be going November 1st to Braun for a few weeks.

Mike G. is going to make a call regarding the portable radios not getting out to the counties and towns. Jim said it's been a problem for years. MARCS will fix it but the Sheriff doesn't seem to want to. The canopy system doesn't work like it should either. Linda commented that multiple towns have been trying to get this fixed for years.

Tammy asked about the last township meeting and the EMS. Jim said they are only exploring options at this point. Tammy would also like for someone to go to the township meetings every month to keep up on what's going on. Linda agrees with Tammy and also believes that Council should be notified from day one what was being talked about. Bradner does not have contracts with anyone for EMS except Perry Township, but provided ambulance services for 60 years to Montgomery Township for free. Bradner does have a contract with Lakota but the money is usually donated back to the school.
