Record of Proceedings February 19, 2018

The regular meeting of the Village of Bradner Board of Public Affairs was called to order at 7:02pm on Monday, February 19, 2018 by Board President James Smith and all present were asked to stand for the Pledge of Allegiance to the Flag. Also present were Fiscal Officer Kerstan Kaminski and Utility Superintendent John Linkey and Guest John Courtney.

GUEST(S)

John Courtney: The last rate study on water and sewer was in 2010. It would cost \$3,000-\$5,000 for each utility. If all done together, this would probably cost \$5,000 total.

He is still looking at the large power customer issue. When the 4% power cost factor rolled into the rates, the large power customers were under billed due to a change not being done in the system. This is fixed now. Certain discounts were also not applied. Retroactive adjustments can be done and limited to one year. This is recommended by AMP & Courtney. Roughly \$5,000 was under billed and \$350/month was overbilled previous to that. This issue was just on the large power customers. Residential and commercial are ok. After discussion, going back one year is probable.

Budget billing for all customers is doable. The reason for budget billing is mainly for electric heated homes. There are more than 5% of Bradner customers with unpaid bills, which is an issue. John C. does not feel budget billing is going to solve the issue. For the constant customers that are behind, they need to have a plan in place to get the past due paid off, not just paying the past due amount every month. Some customers have created their own budget to follow. Courtney works with GAS (Government Accounting Solutions) and SSI (Software Solutions) mostly, but SSI has recently had issues. CMI is for bigger, multiuser cities. He's never heard of Muni-link but recommends a system that really does electricity. Greenwich is currently beta testing Muni-link with kilowatt hour tax.

John C. would not get into any project AMP is doing right now. He would put in as a site for the generators, but that's all. They are natural gas. The smallest you can go is 1000kw. Getting into AMP's behind the meter generation, you'd pay cost. AMP will not assume any risk. A third party could come in and own the project and Bradner would just pay a fee.

Solar energy was also discussed. Solar is not used as a backup, but to reduce load. Current solar prices are \$.06/kwh right now. Energy prices are fixed for 20 years. 13 clients have solar projects installed but none are owned by the towns. They are owned and maintained by the developer. The clients get the capacity benefits. John C. will know in a month some more current prices. Solar can be put within a 300 ft. radius of well fields in this area. They will not be contaminated. Woodville is a great example. AEP, Solar Planet and eTree are companies he knows of. Solar is a great investment. Transmission prices keep going up.

Wind power is not recommended in this area.

The Asset Management Plan also for the last 3 years of information to project for the next 5 years.

John Kreais Jr. made a motion to employ Courtney to do a rate study for Water, Sewer and Electric. Greg Warden 2nd.

John C. recommends net billing if a customer has solar panels or a wind turbine. This is having a bidirectional meter that meters both coming in and going out. They pay for usage at full retail rate and credit for the overage at wholesale. He also recommends an application for interconnection and interconnection agreement. There should be a fee for this. John C. will send copies of this.

John L. contacted Dixon but has no date yet. He's hoping for end of April, beginning of May. Regarding the antenna agreement, Jim doesn't see that Alltel wants to drill anymore holes in the Water Tower, only adding brackets and more antennas.

John contacted Gearhart regarding the Caldwell line but doesn't have a quote yet. He has one from McRill but would like to wait to disclose the amount. He has a quote on 2" plastic line, 500 feet. He still needs pricing on the saddles for the taps. He hopes to have all the information for the next meeting.

LED street lights were ordered. They are probably a month out.

John would like vacation July 19-27.
