### Park/Pool

They have tried to reach out to the community. Hagemann may help with concrete. The poles were donated by DGGI. A boom truck was offered and some electricians have offered time.

### Fire

The annual car show and ox roast is Saturday, July 21<sup>st</sup>. There are flyers printed. The Fire Dept. will not be recommending a new Fire Chief. Applications, resumes and letters of intent will be accepted until July 1 for Fire Chief and chosen that way. Interviews will be conducted by the Fire Committee. Virgil will remain Acting Fire Chief until one is selected. Tom Wildman is working on the bylaws and SOP's. The Firemen are seeking a better relationship with the Fire Dept. and Council. Levi will be starting fire school in October. James Knallay has completed school. The insurance company will be providing information regarding probationary firemen.

The Council discussed and agreed the application process for Fire Chief should stay within the Village at this time.
