UTILITY SUPERINTENDENT - John Linkey:

The battery operated crimper is having issues. It will cost \$1,979.97 to replace through J Harlen. The old one will be repaired, if possible, for a backup. It's almost 9 years old.

Greg Warden made a motion to purchase the battery crimper at \$1,979.97 through J Harlen. John Kreais Jr. 2nd.

John contacted John Courtney today but has not heard back yet. The prices for the solar are \$.05-\$.09. The breakeven point is \$.07. The Board discussed solar regarding battery backup and location and if it would be a possibility. John will ask Mr. Courtney to attend a meeting to discuss further.

John started discharging the sewer today.

The last John heard, House Bill 602 did not affect treatment plants with .2 million gal per day.

The waterline on Caldwell has been filled and pressure tested. He needs to do samples now for testing.

Precision Laser has a R2 antenna unit that Bradner could possibly purchase for GIS. It is slightly used but in good condition and can be used to finish the GIS for the utilities rather than waiting to borrow from the EPA. \$4,425 total cost including the pole. Buying used will save around \$1,000.

Greg Warden made a motion to approve the purchase from Precision Laser with a cap of \$4,500. John Kreais Jr. 2nd.
