STREET COMMISSIONER – Chuck Ruble

The 3 properties on Evans and E. Crocker that need mowed are going to need a contractor to mow them. They are too high for the Village mower. Chuck will get a hold of Erie Mowers.

Brush pickup starts next week. He will also be taking care of uptown before the Car Show.

An estimate came in on blacktopping and milling 6 streets; E Parklane, Spring St, Main St, Railroad St, Blackman and Douglas. The quote from Jennite is \$251,000. It will have to be put out to bid.
