The Village Council of Bradner, Wood County, Ohio met in regular session on the 4th day of October at 7:00pm in the meeting room of the Village Hall. The meeting was called to order by Mayor Virgil Shull and all in attendance were asked to stand for the Pledge of Allegiance to the Flag. Also present were Street Commissioner Chuck Ruble, Fire Chief Tom Wildman, Police Chief Chuck Broshious and Fiscal Officer Kerstan Kaminski and Guest Jim Smith .

RECOGNITION OF GUEST(S)

Jim Smith: Jim is checking on the status of his trees. Chuck has the ordinance that states what trees are acceptable in the right-of-way and the distance apart they have to be. North Branch is having a sale this weekend. Tammy can go and check it out.

Jim also asked about the encroachment around the utility pole behind his rental property. It's causing drivers to drive onto his rental property. Chuck will try to get it next week when he does brush pickup.

STREET COMMISSIONER – Chuck Ruble

Northwood Door put the doors on the schedule. They should be at the park on Friday. All of the parts for the police door are not in yet.

Brush pickup starts next week and leaf pickup will start soon.

Rutter & Dudley quoted the road repair around the catch basin at Railroad and Lightner at \$1,750.

POLICE CHIEF – Chuck Broshious

Firearms qualifications are set up for October 13 in Gibsonburg.

The cruiser camera warranty is expired. It is \$100/1 year and \$200/2 years to renew. He suggests 2 years since the body cameras renew next year at \$190. The renewals will then be on opposite years.

Ray Zaker made a motion to approve the 2 year warranty renewal at \$200. Mike Gudakunst 2nd. Roll Call:

Regarding raising Mayor's Court and impound costs for next year, Chuck suggested raising the court cost from \$85 to \$100. Council already voted in April to raise that cost to \$90. Council does not want to raise it higher than what they already voted on for this year. They will see what happens next year and possibly raise it again then.

A section of Rt. 23 will be closed beginning October 15 for 5 days. This may cause traffic to try to come down Caldwell and go through town. There are signs that prohibit semi-trucks from doing so but they are not always followed.

Lori mentioned the complaining on social media about the officers. 2 Councilmembers said repeatedly to contact Police Chief Broshious and that the cameras can be viewed if there is a discrepancy. The recent stop regarding window tint, seat belt and expired license was viewed. The window tint was proven okay, a warning was given for the seatbelt, and a ticket for the expired license. Chuck has only received one call and it was not from the person that was stopped.

No one is ever stopped just for window tint or seatbelt. The officers will only pull someone over if there are 2 equipment violations, not just 1.

FIRE CHIEF - Tom Wildman

290 runs as of October 2. Average people per run is 3. 2 open burn complaints. 13 EMS runs in Montgomery (5 in Bradner), 5 in Scott (no transports), 2 in Freedom (no transports), 1 in Perry (no transport).

The 2 new stair chairs are in and 13 people showed for the Fire meeting to see them. Northwest 190 is currently using 1.

Tom handed out copies of the surveys he will be handing out at the Open House on Saturday.

The Tanker Committee is going to Arlington to look at a truck. The Bylaw Committee is meeting but there's a lot of work to do.

The station has been cleaned up and a lot of items were donated and thrown away.

627 went to Davidson's for an air leak and an oil change was done.

Wayne, Bradner, Risingsun and Pemberville will be doing pump tests together in a few weeks.

There was structure damage to the east side of the Fire Dept. building. It may just be from freezing but the hood was also knocked loose.
