## **Ordinance 04-2019**

AN ORDINANCE TO AMEND ORDINANCES 32-90 and 12-2018 OF THE VILLAGE OF BRADNER, WOOD COUNTY, OHIO REGARDING FIRE DEPARTMENT WAGES.

WHEREAS, on or about December 20, 1990, the Council of the Village of Bradner passed Ordinance 32-90 which, *inter alia*, established pay rates and benefits for certain employees of the Village; and

WHEREAS, on or about November 1, 2018, the Council of the Village of Bradner passed Ordinance 12-2018 which revised the then-existing fire department wages, which were previously set by said Ordinance 32-90; and

WHEREAS, after further deliberation and careful consideration and evaluation of the finances of the Village and the duties, qualifications, seniority, cost of living, and other relative factors related to said employees, Council has determined that it is necessary to further amend the regulation regarding the pay for certain positions within the Village Fire Department.

NOW, THEREFORE, BE IT ORDAINED BY COUNCIL FOR THE VILLAGE OF BRADNER, COUNTY OF WOOD, STATE OF OHIO, THAT:

Section 1. That, effective January 1, 2019, section 4(I) of Ordinance 32-90, as amended by Ordinance 12-2018 shall be amended to read as follows:

## I. FIRE DEPARTMENT COMPENSATION:

The positions and compensation for the fire department shall be as follows:

- 1. The compensation for the Fire Chief shall be two-hundred dollars (\$200.00) per month, to be paid from the Fire Fund.
- 2. Assistant Fire Chief shall be compensated one-hundred seventy-five dollars (\$175.00) per month, to be paid from the Fire Fund.
- 3. Two Fire Captains shall be compensated fifty dollars (\$50.00) per month, to be paid from the Fire Fund.
- 4. Two Fire Lieutenants shall be compensated thirty dollars (\$30.00) per month, to be paid from the Fire Fund.
- 5. Volunteer fireman shall be compensated one dollar (\$1.00) per year, to be paid from the Fire Fund.
- 6. One EMS Captain shall be compensated one-hundred fifty dollars (\$150.00) per month, to be paid from the Ambulance Fund.
- Section 2. All other provisions of said Ordinances 32-90 and 12-2018 not specifically amended herein shall remain in full force and effect.

Section 3. All formal actions of Council relating to the adoption of this Ordinance and all deliberations of Council to such action were in meetings open to the public as required by Law.

Section 4. That this Ordinance shall take effect and be in force at the earliest time permitted by law.
