The regular meeting of the Village of Bradner Board of Public Affairs was called to order at 7:00pm on Monday, April 15, 2019 and all present were asked to stand for the Pledge of Allegiance to the Flag. Also present were Fiscal Officer Kerstan Kaminski, Utility Superintendent John Linkey, Utility Clerk MaryLou Evans and Lineman Jerrame Allgire.

One bid was received for the Light Plant roof from CRM at \$141,947 for the metal roof and \$109,189 for shingles.

GUEST(S)

Wilma Caldwell: She would like to be able to make her payment May 3rd. She can pay \$100 on 4/19 and \$224.41 on 5/3. She gets paid again on 5/16 and will have the May bill paid by the end of May.

UTILITY CLERK – MaryLou Evans:

MaryLou gave copies of adjustments to the Board. Per the auditors, any adjustments need to be approved by the Board monthly. Marylou explained the adjustments.

So far 40 income surveys have come in not including the 20 that MaryLou has received.

MaryLou will be gone April 24-26 for Mayor's Court training.

GUEST(S)

John Courtney: Eitri will be at John's office later next week. John modified the net cost of energy supplied by the solar project. With all involved, the net cost of energy will be \$0.007 per kwh.

There is no storage with the solar project, only demand. First Energy and PJM are requiring installation of a reverse flow relay to prevent pushing power to the grid which will have some cost associated with it. Bradner would have to curtail the overage which could also have some cost. When Oak Harbor and Woodville put their projects in a few years back, First Energy did not charge for a load study. First Energy has changed this and is now charging for this study. Mr. Courtney can speak with Eitri about paying for the study and adding that into their cost over so many years. Solar is a great way to reduce load at high peaking times since 30% of the bill comes from transmission costs. 35% of Bradner's energy comes from

hydro. An initial application was started and the price came back at \$10,000. Eitri is waiting to see if Bradner wants to go ahead. Mr. Courtney recommends going ahead with the study whether Eitri will pay the \$10,000 or not.

John Raymond was filled in on why Bradner has decided to do solar and background information.

Greg Warden made a motion to submit the application to First Energy for a detailed load study for \$10,000. John Kreais Jr. 2nd.
