## **RECOGNITION OF GUEST(S)**

**Eidenour/Harden/Taulker:** They did more research on the Kids Council and gave a handout to Council with information they would ask someone who wants to join. They made a sign up form. Council suggested the name be Bradner Kids Council. Council questioned whether kids from out of town can be on Bradner's Kids Council and will have to check with the Solicitor.

The Solicitor says the fundraiser needs to be more specific as to what they will be doing with the 25% they are keeping. They would like to get uniforms that label who they are and tools they need to continue on.

They heard some misinformation regarding losing the Police Dept., which was not true. The Police Dept. reduces their hours at the end of the year.

## **STREET COMMISSIONER – Chuck Ruble**

Northwood Door will be installing the Police door next week. The brick work on Town Hall is done.

The mosquito sprayer will be in Toledo Tuesday to be tested and calibrated.

Chuck has been doing brush pickup all week. It will probably be into next week. Rules are not being followed and it's being taken advantage of. The brush pickup will continue this year but it may be changing to a drop-off next year. The comment was also made that chipping is a dangerous job for only one person. Residents blowing grass into the streets are being notified it is illegal and it needs to be picked up.

#### **POLICE CHIEF – Chuck Broshious**

Bradley Kash was on auxiliary and has moved on to another department.

Chuck and Jontez went through the evidence room; 100 cases total. As soon as the Prosecutor approves, the property will be disposed of in some manner.

Tom Wildman would like to use the bodycam footage from the recent Timmons Rd. incident for training purposes.

#### **FIRE CHIEF – Tom Wildman**

\$600 from the Comedy Show will go into the New Fire Station fund.

Per Virgil, Critical Infrastructure can be used for the New Fire Station up to \$700,000. Since the tankers/ambulances are no longer fitting into the station, it qualifies for this grant. However, the Board is also applying for the grant for the Caldwell waterline project so Virgil will check if this is even possible.
