RECOGNITION OF GUEST(S)

Jerry Houtz: They signed their contract Tuesday with Superb Structures for construction. Closing on the loan should be Monday. Construction should begin next week and finished completely Dec. 31, 2019. They could go in service at the latest Jan. 1, 2020. Superb was the lowest bid and chose local contractors. Stahl Electric will be doing the electric, B. Hillz will do the site work, and Gearhart will be doing the plumbing and heating. They are borrowing \$400,000 through State Bank and paying back over 15 years strictly with general fund money. Ambulances were purchased. They were lettered by DGGI. They are posting notices for Chief position applications, which will be hired first. It does require a paramedic license. They are hoping to start interviews by August 1st.

The trustees are paying the whole portion of the building. This will also never affect any other future projects.

STREET COMMISSIONER – Chuck Ruble

The mosquito sprayer tank was leaking and a new tank was purchased.

Jennite quoted the tile on Cherry St at \$15,910. Chuck is waiting for a quote from B. Hillz. A catch basin will be on the west side of W Parklane and the tile will go straight down to E Parklane. Another catch basin will be put in by the telephone pole halfway down Cherry to E Parklane. This will help with the surface water and sink holes in this area. The area homes can tie into the catch basin if they choose to. Chuck reiterated that the tile behind the Stahl residence were not broken.

Mosquito spraying will be Mondays or Wednesdays starting at dusk. If the weather does not permit spraying Wednesday, it will be done the following Monday.

B. Hillz will possibly be helping install the park equipment and possibly basketball hoops. They will be giving a price for this as well.
