Tom will be attending the Montgomery Township meeting this next Tuesday to find out what their backup plan is if the Fire levy fails. The EMS levy that passed is completely separate from the Fire levy.

Bradner will be First Responders for 911 calls South of 6, West of 23 and North of West Millgrove once the Southeast Ambulance District is up and running.
