Critical Infrastructure was rejected due to the county's resolution having the wrong entity's name and the administrative cost also being incorrect. Poggemeyer will get those corrected and resubmit them.

Issue 1 application was submitted on Friday for the Water Tower Rehab project. It was submitted as 50% grant, 50% local.

H2O Towers will be in Wednesday to start cleaning the water tower.

Eitri's proposal came in at \$.075 or \$.071 depending on when the project gets done. Mr. Courtney is double checking on this. Kerstan still has not heard back regarding the Cost Reimbursement Agreement

that she sent back to Ryan with AMP. Board would like to have a resolution for the Power Purchase Agreement and the Lease Agreement for Council next Thursday but would like to have ready at their meeting Monday for review.

Per Virgil, Council needs help with brush pickup for September. The new Street Commissioner is unable to begin working due to an injury. Board will assist this month. John Raymond will pickup for the Food Giveaway. Ron Youngs will help out with mowing.

John wants to get 5 meter pits changed out before fall. He also wants to get the lights and poles done at the park soon.

118 W Parklane has had 2 emergency call-outs due to a tree trimming company knocking out electrical lines. A bill will be sent out for these call-outs.
