They are doing a Chicago bus trip and checking to see if they can invoice the Village for that expense. There is also a craft and bake sale next Saturday at Town Hall to raise money.

## **POLICE CHIEF – Charles Broshious**

The Owens training programs went up \$100, from \$400-\$500.

### FIRE CHIEF - Tom Wildman

They met with the Montgomery Twp. trustees Tuesday and there is still an issue getting paid for uninsured runs. The subject was tabled again. 31% of runs are for uninsured persons. He also feels Council should sit in at the next meeting.

The new tanker will be delivered Dec. 21<sup>st</sup>. Radio Hospital will remove MARCS radios on Dec. 20<sup>th</sup> and reinstall in new tanker on 23<sup>rd</sup>.

There will be 3 interviews at the next Fire Committee meeting next Thursday.

He put in for another grant, \$24,000, 8 more MARCS radios including battery chargers.

Senator will be attending a Council meeting when she has more information regarding other avenues for a safety building grant. She believes they are some issues right now.

They are currently at 320 runs for the year.

The tanker sold for \$7,750.
