RECOGNITION OF GUEST(S)

Greg Warden- BPA: Bradner was awarded the Critical Infrastructure grant in the amount of \$411,000 to do the Caldwell waterline project. The line will run from the water tower to St. James Church. This project has a tentative date to start sometime between July and September of this year.
