## **POLICE CHIEF – Chuck Broshious**

Ryan Leroux resigned.

Officer Widman passed his FTO and is now part-time.

The rest of the evidence in the property room is now able to be destroyed. Chuck gave a short update of a few recent cases. Evans case has been continued to September 8.

#### **RECOGNITION OF GUEST(S)**

**Jerry Houtz**: Montgomery Twp. Trustees authorized \$1,500 each to Bradner Fire Dept., Wayne Fire Dept., Risingsun Fire Dept. and Southeast 150 from the CARES Act. They need receipts. Jeff would like to purchase a sanitation device (\$2,000) and UV light. Montgomery may be able to give a little extra money.

Mr. Snyder has resigned as Chief for Southeast 150. Mr. Althouse is the Interim Chief and is doing great. They've posted the position and hope to have a new Chief by October-November.

The EMS Board told Perry Twp. they are not interested in taking them on contractually and at less than Montgomery Twp.'s millage. Perry would have to become part of the Southeast Ambulance District and pass a 3.5 mill levy, which is not probable. Montgomery Twp. could lower theirs to 3.5 if Perry passed a 3.5. 150 will not service Perry Twp. for less than Montgomery Twp. residents are paying. Perry is currently putting on a .5 mill levy in November. The EMS Board and Interim Chief are not actively seeking Perry Twp., the previous Chief was. Without the 3.5 levy from Perry, the ambulance situation will stay the same as it's been with Bradner.

They will be starting a third full-time paramedic by first week of September. They will be 24 on, 48 off shifts.

Council would like Mike Gudakunst to attend Council meetings to report from the Southeast EMS Board meetings or at least pass on any information. However, they did not meet in March and April and nothing major was happening besides the recent resignation of the Chief. Mike has been doing great as a member of their Board. Tammy will also speak with him.

Jeff did express concern with lowering to 3.5 stating it may make things tight. He suggests at least between 4 and 5 due to wages increasing and new equipment.

A suggestion was made to have caution/warning signs regarding emergency vehicles out at 150.

#### FIRE CHIEF – Tom Wildman

Another application was received for an EMT.

The bylaws and SOG's will be done at the next Safety meeting on the 10<sup>th</sup>. They will then go to the Fire Dept.
