### POLICE CHIEF'S REPORT -Chuck Broshious

The Ford Explorer had a new battery installed.

Officer Adam Widman has completed a 2day ICAC class that trains officers on how to identify and charge sexual predators using a cell phone. To date we have had 2 successful cases, 1 assault, and 1 arrest.

The vandalism of the restrooms at the park is in the process of being wrapped up. The case will likely end up in juvenile court.

Training will be with Pemberville on Saturday for firearms, tasers, batons, and pepper spray. This will be an 8hour session

### FIRE CHIEF -Tom Wildman

Hose testing is completed with 700 feet of hose being tested, 200 feet failed.

Chief Wildman reported that he has two EMTs that will be taking their national registries. A Harlan Chicken BBQ will be happening the 3<sup>rd</sup> weekend in July with the car show. He requested that the streets be closed off for this event. The tickets for the BBQ will be presold. The event will be July 17<sup>th</sup> from 8a.m to 3 p.m.

Speedways is thinking about having some events the same day with the possibility of a beer tent and a band.

Tom asked if the pool house will remain on the park property. There are no current plans to tear it down. He would like to keep using it for fire drills. Tom mention a complaint that was made by a resident regarding the HIPPA law. He tried to follow up with it but was unable to get a response back from the complaint.

### ORDINANCES & RESOLUTIONS

- a. Ordinance 6-2021 – Second Reading. An ordinance to amend Chapter 181 of the Codified Ordinances of the Village of Bradner, Wood County, Ohio regarding filing and remittance deadlines for municipal income tax of the Village of Bradner.

### BUSINESS OF THE MAYOR-

The Huntington account that the village has is changed with a higher credit limit and a new package to allow the village to be updated with new features. The new Fiscal Officer is now on the account. All accounts that are in the village's name now have at least two administrators on each account.

The village received a letter from a resident, who is a minor, apologizing for the damages that she did to the toilet paper holders in the women's bathroom at the park. It was read to council. She has picked up litter at the park on several occasions to try to compensate for her actions. Her mother has been in constant contact with the Village over this incident and has fully cooperated with the police.

Tammy revisited the liquor control letter from the Ohio Department of Commerce that the village received for council to approve the renewal of the liquor license for Speedways Bar and Grill. Council agreed that we had no reason not to approve it. We will not need a hearing.

#### ADMINISTRATOR-JOHN LINKEY

The well report is complete and was presented to council.

The discharging at the lagoon was started on May 3<sup>rd</sup>. The first two weeks was good but awaiting info in the third week. Linda asked John about the 3<sup>rd</sup> week report and John explained that the first two weeks were cloudy and colder than the third week.

We are awaiting approval on the behind the meter ordinance for solar customers. It was determined that backup generators that have to be installed because they are behind the meters would need a zoning permit.

The work at 126 W. Crocker St. of the service lines is complete.

John reported that the wheel is broken on the grater again and will need repaired.

Our new street commissioner is doing a great job so far.

Potholes throughout the village have been filled. We used approximately 3 ton of coal patch.

The bid opening for the waterline project from the sewer building the village limits on Caldwell Street will be begin May 25<sup>th</sup>. This will include 1500 feet of 8" pipe. John stated his concern about the cost of the pvc pipe rising in cost. This could increase the cost of the engineer's estimate.

Mosquito spraying throughout the village will begin on the 23<sup>rd</sup> of May at dusk and will be done each Wednesday weather permitting.

Shawn asked John if he took the mosquito sprayer in for testing and John said that he did. This information will be put on the village facebook page.
