POLICE CHIEF'S REPORT -Chuck Broshious

Police report given at beginning of meeting, out of order due to swearing in of new officer, Colton Ball. Chuck reported that he is awaiting an estimate from the Ford dealership in Fremont for the police cruiser to compare to the one from the dealership in Bowling Green. Also, the investigation is still ongoing for two theft cases within the Village.

FIRE CHIEF -Tom Wildman

Tom had expressed his concerns in regards to the bills from Ardent Technology, he wishes for them to be better itemized and that he is notified before any work is done at the Fire Station such as cost of job to be performed.

Safety Day will be September 25th. The Health Dept. will be providing Covid vaccines from 11 am to 3 pm at the Fire Hall and are hoping to have Booster Shots as well at no charge. Sandy Wichman from the Sheriff Dept will be in attendance for vehicle safety for younger children. Fire training for the kids. The fire safety trailer will be here. Demo with the Jaws of Life on a car. There will be food available and a bake sale as well.

Tom accepted the grant from FEMA for the purchasing of rescue tools after last council meeting. He is gathering quotes with 2 more companies for the equipment. Oct 4th Hearst Rescue Tools will be here for demonstration of tools available and Halmpo will come by on another date.

Tom reported that Latta's office is still saying the grant for the new fire station is still possible.

Shawn inquired about demos being done on cars at the lagoon and Tom said one will be done on Safety Day within the Village.

ADMINISTRATOR-JOHN LINKEY -

John reported that the grant work has been submitted for the Water Line and House Bill 168. He has not heard yet on score/ranking on it.

He is seeking estimates for right of way clearing of trees around the lines without using our new bucket truck.

On Friday, he will be listening to a conference call of Prairie State hoping that the state of Illinois has made decisions in legislations that will help as having ownership of Prairie State.

John asked council what their thoughts were on the Neighborhood Revitalization Grant. As there is a cost and no guarantee that we'd get anything. The grant would be for an infrastructure within the community and a minimum of 3 projects must be presented. Linda asked for John's ideas. He suggested Downtown Streetscapes, Curb repaving, etc; Waterline replacement on Crocker St; LED Street Lighting downtown. Shawn asked about the application cost in which John said it could be \$20,000 to \$30,000.
