VILLAGE ADMINISTRATOR-JOHN LINKEY -

The Caldwell waterline project has started. Terry James asked John about the project interfering with residents getting in and out of their driveways. John said that he would talk to the contractor. Discussion and update given by John in regards to the project for placement and costs. The change in order of the cost of \$ 57,000. The original amount of the grant was \$411,000 with \$30,000 in administrative costs leaving \$381,000; \$303,000 was original bid with the change bringing it to about \$360,000 which leaves a cushion yet. John brought up about the appointment to the Voluntary Fire Dependence Board and Linda asked to wait until the next council members come in to office.

Shawn inquired about the waterline break call on Timmons Rd the day after Thanksgiving and how long it took to get it fixed. It was fixed that day by John along with the help of Chris and Jimmy.
