The Village Council of Bradner, Wood County, Ohio met in regular session on the 16th of June, 2022 at 7:00 pm in the meeting room of the Village Hall. The meeting was called to order by Mayor Tammy Kreais and all in attendance were asked to stand for the Pledge of Allegiance.

POLICE CHIEF'S REPORT- Adam Widman in place of Chief Broshious-

Northwood Door installed a security plate for the police department door.

Adam discussed his recent training classes which included OVIs for Drug Impaired Cases, Testifying in Court, Police Department Interview and Tactics were free at Owens with the exception of Police Department Interview and Interview Tactics.

Adam addressed the questions from the previous meeting from Terry James on the nature codes and descriptions on the monthly police reports given by the Chief. He informed council that the Ohio Buckeye Association Code is used.

Jeremy Salaz's body armor vest was received. Adam is still waiting on his and the Chief will be ordering one as well since his is over 10 years old.

Ray Zaker asked Adam about the house at Timmons and Crocker and the stakes that she has put around the curve and corner of her house to keep vehicles from going in her yard when they turn. He stated that the village isn't paying for any damages of vehicles and it was their property and not hers. He felt that they were too close to the road and that the village could be held liable. Terry felt that it is her property to maintain and that she has been doing it for years so that he had he didn't see a problem with it.

FIRE CHIEF'S REPORT- Tom Wildman

Tom stated that there have been several runs, including the fire in West Millgrove, for EMS assistance and the house fire on Bradner Road just outside of town. Currently he has about 20 hours into it with the State Fire Marshall's Office and the investigation will end up in the prosecutor's office.

The fire department would like to have the trees and stumps taken out on the village lot where the new fire station will be built. He said that they could take the money out of the New Fire Department Fund.

Lori asked Tom when he anticipated that the building would start and was the grant from the state or government. She also asked if we were using the drawings that were previously shown to council.

Tom said that he has not received the grant details as of yet but as soon as he hears from the State of Ohio he will know more. John Linkey said that the drawing shown previously to council was just a concept drawing.

Tom reminded council of the car show on the 16th of July. The fire department will be honoring a 55 yr member at the show.

Tom informed council that his company would remove chemicals from the pool house as a community service project. He anticipates that it should be done by the end of summer.

Tammy informed council that her and John had been pursuing a grant for the restroom at the townhall to make it ADH compliant. They attended a meeting at the Wood County Commissioner's office and then Tammy attended the award meeting recently and the village will be receiving 78,000.00 to complete this project.

Tammy thanked John and Jimmy for their work during the recent power outages and Tom for his department's hard work with the recent fire. Many residents praised both.
