IT IS THEREFORE RESOLVED BY THE COUNCIL OF THE VILLAGE OF BRADNER, STATE OF OHIO, AS FOLLOWS:

SECTION 1.

That the Village shall engage Scott J. Heacock as the Criteria Architect for the construction of the Village Fire Station, pursuant to the USDA-approved terms and conditions set-forth in a certain Letter of Understanding dated March 12, 2023, which letter is attached hereto and incorporated herein as "Exhibit A."

SECTION 2.

The Mayor of the Village, the Village Administrator, and the Village Fire Chief are all hereby jointly empowered and authorized to execute any and all such documents necessary to effectuate such engagement and bind the Village thereto.

SECTION 3. Effective Date:

This resolution shall become effective from and after its passage at the earliest period allowed by Law.

SECTION 4. Public Meetings:

All formal actions of Council relating to the adoption of this resolution and all deliberations of Council and any of its committees leading to such action were held in meetings open to the public, as required by Law.
