The Village Council of Bradner, Wood County, Ohio met in regular session on the 2nd of November, 2023 at 7:00 pm in the meeting room of the Village Hall. POLICE CHIEF'S REPORT-Jeremy Salaz – Jeremy presented council with the monthly police report. Also, the zoning report for the month was presented. Jeremy did send a thank you card and letter to the American Legion for their donation to the police dept. Two weeks ago, a hiring notice was posted at the police academy for part-time officer. There have been no inquiries as of yet. Dan asked if the zoning report can include cases still within Mayor's Court. Jeremy will look into this.

FIRE CHIEF'S REPORT- Tom Wildman- Tom and John have been working on a new reporting system with a 2-hour webinar training this past Monday and another 2-hour next week. Two letters of resignation have come in. Tom read Brett Linkey's letter to council. His will come into effect as of 10/31/2023 as he is moving out of the village. He wishes to stay on as a charter member of the fire association and continue with the planning of the new fire station. Tom also read Joe DeLong and Malinda Machefski's letter of resignation to council. They are also moving out of the village. Their letter was dated 10/28/2023. In reaction to the letter, council woman Linda asked Tammy why she had mentioned her name to Joe regarding him leaving the department. Whatever is between herself and Tammy should not be spread around and that she prefers Tammy to not mention her name. The letter was emailed directly to council man Terry to distribute it to the council and Fire Chief. Motion to accept the resignations of Brett Linkey, Joe DeLong, and Malinda Machefski was made by Dan, 2nd by Terry. Roll Call: Yes: Lori, Ray, Dan, Mike, and Terry. Abstain: Linda. Motion carried. The department is in the process of getting new foam. Tom is hoping to have someone that will take the old foam to get rid of it. More information to

come on this. Next Thursday at the Safety Committee Meeting they will discuss what has come in for the RFP for the new fire station. The deadline for the RFPs is Nov. 9th at 5pm. Four letters of intent have been sent back to us.

ORDINANCES & RESOLUTIONS -None to report.

BUSINESS OF THE MAYOR – Tammy-North Branch Nursery contacted John, they donated 10 trees at a \$1,220 value. They will be planted by us. The Friday after our last council meeting, Scott, John, and herself met. Scott made a new addendum that was sent out for the RFPs. Tammy requested an executive session at the end of the meeting. Trick or Treat went really well this year. Many turned out for the judging. Approximately 400 kids came through the fire station.

BUSINESS OF THE VILLAGE ADMINISTRATOR – John Linkey-John presented council with the Well Report along with Jeannie's utility clerk reports for Water Consumption, Sewer Consumption, Electric Consumption, Billed Monthly, and Summary Cash Receipts 2023. John gave a letter to the Mayor and an executive session will need to be done for it. The water line project has been pushed back again until March. Fremont Fence was out yesterday and started the quotation process for the fence around the generator. Neptune 360 reading system is continuing working on a program that will include electric readings as well; nothing definite as of yet.
