

Ordinance No. 14-2020

**ORDINANCE ESTABLISHING THE POSITION OF VILLAGE
ADMINISTRATOR AND ELIMINATING THE BOARD OF PUBLIC AFFAIRS
WITHIN THE VILLAGE OF BRADNER, OHIO**

WHEREAS, the Village of Bradner has a Board of Public Affairs created pursuant to RC §735.28 to manage, conduct, and control the waterworks, electric light plants, artificial or natural gas plants, or other similar public utilities, furnish supplies of water, electricity, or gas, collect all water, electric, and gas rents or charges, and appoint necessary officers, employees, and agents; and

WHEREAS, pursuant to Ohio Revised Code §735.271, the Council of the Village may establish the position of Village Administrator; and

WHEREAS, pursuant to RC §735.272, upon the creation of the position of Village Administrator, the Board of Public Affairs shall be abolished and the term of office of members of such board shall terminate; and

WHEREAS, after careful consideration, the Council has determined it to be in the best interest of the Village to establish the position of Village Administrator and abolish the Board of Public Affairs.

IT IS THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF BRADNER, STATE OF OHIO, AS FOLLOWS:

SECTION 1. VILLAGE ADMINISTRATOR CREATED

- A. The position of Village Administrator is hereby created, effective January 1, 2021.
- B. The Village Administrator shall be vested with all powers, duties, and responsibilities pursuant to law, and any other such duties as fixed by Resolution of Council, from time to time.
- C. The salary of the Village Administrator shall be fixed by Resolution of Council.

SECTION 2. BOARD OF PUBLIC AFFAIRS ABOLISHED

- A. The Board of Public Affairs of the Village of Bradner is hereby abolished, effective December 31, 2020 at 11:59 P.M.
- B. The term of office of any such member of the Board shall terminate, effective December 31, 2020 at 11:59 P.M.

- C. All contracts entered into by said Board of Trustees of Public Affairs and rules and regulations and other action taken by such Board shall continue in effect until they have terminated of their own accord or until they shall have been modified, changed, revised, amended, or repealed in the manner provided by law.


SECTION 3. EFFECTIVE DATE

This Ordinance shall become effective from and after its passage at the earliest period allowed by Law.


SECTION 4. PUBLIC MEETINGS


