POLICE CHIEF'S REPORT- Police Chief Cory Fairbanks has nothing new to report. Ray inquired about the radar that is in the police cruiser and if a new one is needed. Cory reported that we have a new one on order.

FIRE CHIEF'S REPORT-Tom Wildman- Chief Wildman reported that he received a message that there will be controlled burn for agricultural waste out on Wayne Rd and was passed through the Ohio EPA. Unit 621 will be picked up on Saturday from Cridersville, it's been there for two weeks. Tom will forward the invoice once it comes in. Three additional masks are needed to be ordered, bringing the total to 23, Tom asked for a PO to be submitted for this. He will get Angie the new roster on Monday. Tom asked that the snow that is on the side of Jeff's building be moved so they are able to park there when runs come in. Tom said he will have the end of year report at the next council meeting.

ORDINANCES & RESOLUTIONS – no new legislations to report.

BUSINESS OF THE MAYOR - Mayor James-Terry reported he had nothing new to report.

BUSINESS OF THE VILLAGE ADMINISTRATOR-John Linkey-In regards to the houses being built by Habitat for Humanity, originally facing Maple Street, now will be on Lightner St. and address numbers are needed; 401 will be for the corner lot and 409 will be for the other lot. John will follow up with the Habitat for Humanity. Regarding the Timmons Rd project, do we wish to pursue the construction and the loan process. Provided to council were the loan information sheets for the full cost of the East/Edmonds/Evans waterline project and the Timmons Rd waterline project design loans including the loan payment amounts. Currently we have a 0% for 5 years loan for the design portion of the Timmons Rd project. The loan payments come from Water Capital Fund. Last year we received approximately \$118,800 in utility income along with \$22,800 from the Verizon rental. John advised council that we should wait a few years, unless we were offered a loan with principle forgiveness, plus within a few years several of the small payment loans will be paid off.

The Village Appearance committee will meet as needed.

NEW BUSINESS- Shawn received a call from Tim Ruble this evening, stating there is a meeting coming up this Tuesday, January 21st at 6:30pm at the Montgomery Twp. building. He would like as many people that could come and join the meeting the better. Union Carbide is looking to build a new building for the township on the wooded property on Graham Rd.
