POLICE CHIEF'S REPORT- Police Chief Cory Fairbanks has nothing new to report. At the next Finance Committee meeting on the 16th of January, Cory would like to present information to the committee.

FIRE CHIEF'S REPORT-Tom Wildman- Dave Bankey was in attendance. Tom introduced him to the council as he was appointed as Lieutenant. With the Sheriff's system and CAD system being down, they have to watch how they respond as the address will not come across their pager or phones they have to be sure to write down the address. They are having to keep track themselves on times. The ambulance has been fixed the O-Ring on the fuel filter was leaking. The invoice is with tonight's bills. Tom ordered new foam and it should arrive next week. He has one going to First Responder School after the 1st of the year. Scott Township contract has come in and has been given to the solicitor to review. Reid has signed and returned it to us. Tom reported that the Fire Station Bld. Committee met and that all notes that came in red and all concerns went to Kyle and have been addressed. Pictures of the building have come in. Once the sign comes in and put in place, we will update the community. One firefighter will be going through the 200 hour Fire School at the Penta Career Center or Fremont and will be getting their physical done as well.
