RECOGNITION OF GUESTS NOT ON THE AGENDA 5 MINUTE LIMIT: Joshua Woerner, new police officer was sworn in by the mayor. Josh is certified and ready to go and is familiar with Wood County.

POLICE CHIEF'S REPORT- Chief Fairbanks-Chief Fairbanks and Officer Senyo were in attendance. Cory spoke with Officer Ali in regards to the four-wheeler incident and Linda asked that he will also follow up with the resident who had the complaint, Cory agreed to do so. Cory again asked that if anyone receives a complaint to ask the individual to come to a council meeting and/or contact the chief himself.

FIRE CHIEF'S REPORT-Tom Wildman- Chief reported that Conner Beck has completed his Fire Fighter 1 with a score of 80, ready to start his Fire Fighter 2 class and is going to start EMT Training as well. That way he will have all 3 of these done before he graduates high school. David Bankey will be going out to 150 for EMT Training. Tom gave Angie the first safety flyer to go out with the November 1st utility bills. This month's is on Carbon Monoxide.

The 3 phase poles have been run in the alley. We will get the signed Spring Street quote sent back to Morlock on Friday. Not sure yet if it will be able to be scheduled to be done yet this year.
