The Village Council of Bradner, Wood County, Ohio met in regular session on the 4<sup>th</sup> of December, 2025 at 7:00 pm in the meeting room of the Village Hall. The meeting was called to order by Mayor, Terry James and all in attendance were asked to stand for the Pledge of Allegiance.

RECOGNITION OF GUESTS NOT ON THE AGENDA 5 MINUTE LIMIT: Matt Herrig, village resident has submitted a letter and application of interest in the open council seat for next year. He wanted to introduce himself to council. Village resident, Sheila Entsminger was also in attendance just to observe. POLICE CHIEF'S REPORT- Chief Fairbanks-Chief Fairbanks asked if we had heard back from Reid in regards to the possibility of putting \$10,000 to \$15,000 of this year's unspent police budget into the Police Capital Fund for a new cruiser in a couple of years? Terry spoke with Reid and he will have us information before the next meeting. Cory needs to speak to Eric as Cory wishes to have the cameras coming from this year's budget. Terry reported that Eric does have the cameras ordered but not yet received. Complaints have been received about a vehicle parking in the wrong direction on Crocker Street. Cory will look into this. \*\*Cory came back later in the meeting to report that they spoke to the resident in question.

FIRE CHIEF'S REPORT-Tom Wildman- Chief reported that he is continuing to work on the grants as discussed at the last meeting, the one for SCBA's Tom signed for that one. He believes he has a possibility of grant funding for the generator needed for the new fire station. He did receive a quote for the flashlights discussed at the last meeting, this one being through United Fire Apparatus. Interest was shown in Unit 627, Virgil took it to Bucyrus for them to look it over. On Saturday, the fire truck will bring Santa, Mrs. Claus and the Grinch from the fire station to the light plant for the tree lighting ceremony and gathering. The fire dept. is currently running a fundraiser of two boards, \$25/square for the National Championship and the Super Bowl. The safety flyer going out with the upcoming utility bills is "Prevent Youth Fire Setting". Once patches come in, Tom reported he will have 2 firefighters to be sworn in. ORDINANCES & RESOLUTIONS —

Jaime will be available for any issues. Also, Cameron is off the 26<sup>th</sup>, 29<sup>th</sup> and 30<sup>th</sup>, and Jan 2<sup>nd</sup> back on the 5<sup>th</sup>. Linda asked if there were any judges aligned for the lighting contest if not, she will get them lined up.

SOLICITOR'S REPORT-Reid Rothenbueller-not in attendance.

BUSINESS OF THE FISCAL OFFICER-Angie continuing to work on the temporary and permanent appropriations for next year and have ready for council's approval at the next meeting.
